(this week) that was expected to be highlighted by a visit from State Comptroller Tom DiNapoli.

"We expect the comptroller to show up and I'm expecting there will be a picture taken of him with our candidate for mayor of Niagara Falls, Robert Restaino," said Democratic Chairman Jason Zona on Monday.

Restaino will have a tight squeeze timewise to get that picture taken with DiNapoli because somehow, former Democratic Chairman Nick Forster is throwing a \$500-a-person fundraiser for Restaino at the Red Coach Inn about the same time as the Democratic picnic at Gratwick Park. Coincidence? Or is there a political rivalry between Zona and the former chairman?

Zona expects, and so do we, that Restaino will make both events and get his picture taken with the state's chief fiscal watchdog who has been a critic of the current administration's handling of casino funds for several years.

Republicans will have their get-together next Tuesday, July 23, at the Hyde Park Stonerom where they are expected to have a loud and upbeat crowd for their very strong slate for Niagara Falls Council, incumbent Ken Tompkins and newcomer John Spanbauer who, if they win the two seats up for grabs, could give the GOP the majority on

the council along with Chris Voccio.

The city GOP has still not made an endorsement for mayor and there are rumors the party is not too excited about backing former Democrat Glenn Choolokian. Some are said to be favoring Democratic primary winner Restaino for the top job. Choolokian has not been seen much by the GOP faithful, according to reports, and we'll have to wait and see if he shows up on Tuesday for the \$50-per-person event.

The fight for political power goes on even as the legal battle between the state and the Senecas over revenue-sharing payments goes on, tightening the financial noose every day for the three host cities, Niagara Falls, Buffalo, and Salamanca.

"We still had about \$7 million on hand a few weeks ago," said Council Chairman Andy Touma, but the savvy leader admitted there is still much uncertainty about when there will be a settlement and if so, what kind of financial money will be flowing from the Senecas. Will it be the same as before?

As we have reported, the Senecas don't feel they have gotten the "exclusivity" bang for their more than \$1 billion in bucks paid to the state since the compact began. They want a new deal and have balked at paying the state \$255 million as ordered by the arbitration panel in April following the December decision favoring the state.



New York Governor Andrew Cuomo has remained silent on when the State will receive all of the money owed from the Seneca Nation.

As of this week, the state and the Senecas have until Aug. 27 to file their briefs in support of their motions in the case that is now before U. S. District Judge William Skretny.

While all that moves along -- or doesn't move -- the state is still holding on to the \$12.3 million it promised to loan the city of Niagara Falls for the current budget until the Seneca money comes in. Well, when or if the money will be coming in remains very uncertain, and while the city still has money in the drawer, it won't last much longer.

Perhaps the city can breathe easy, however, as the state said in an email to this reporter on Monday "the state is in contact with the Niagara Falls Mayor's office, and our commitment to the city remains firm

as we wait for the Seneca Nation to fulfill its obligation as determined by the arbitration panel."

Well, the state seems ready to deliver on its promise if necessary, to keep the city from falling into the Niagara River financially, but what about the future? Will the slot revenue payments resume at the same level? Or will they resume at all? All that seems very much up in the air these days as the politicians move about hoping to take control of a dying city.

There are numerous reports around town that businesses at many locations far from the state park are not doing very well this summer. As one businessman put it, this is a poor city and getting poorer. The state needs to step up but so far, it hasn't.

Chris's Corner: Ending One Party Rule in the Falls

With the primary elections behind us, and with an unusual mayoral race ahead that could give us a mayor elected by a slim plurality, my focus during the general election will be to help bring about historic change on the City Council.

It's important to understand that the City Council, the legislative body of the city, has been under One Party Rule for decades. Someone told me it was back in 1964 that we last had a Council with a Republican majority, others have said it was back in the 1980's. Whichever

is correct, it is fair to say that the Democratic Party has controlled the Council for more than a generation. For decades.

Drive along Pine Avenue or Niagara Street. Drive up and down Highland Avenue or Main Street or Hyde Park Boulevard. If you like what you see, if you're happy with the progress the city has made with One Party Rule, then it may make sense to keep that party in control of the City Council. If you like the condition of our city streets, the sidewalks and the business climate, then keep the current majority party in charge.

Please understand that since the casino opened, the city has received \$250 million in casino revenue. While some want to blame the mayor alone for the way those casino dollars were spent, the mayor can't buy a pack of chewing gum with city funds unless it's approved by the City Council. The same City Council that has been controlled by One Party Rule. For decades.

So as you drive along the city's streets, if you are unhappy with the way things look, please remember

that \$250 million, over and above the city's regular budget, has been pumped into the city. Are you happy with the way things turned out?

Whatever you think about the two major political parties at the national level, clearly it's unhealthy to have one party control the keys to government for so long. We're now witnessing the issues associated with One Party Rule in Albany, and it's only been six months of one party dominance there. Let's hope that it doesn't last for decades, as it has here in the Falls.

Whichever party you belong to, and whichever way you normally vote, I'm urging you to consider voting for two Republicans in this City Council election in November, incumbent Kenny Tompkins and political newcomer John Spanbauer.

Give Republicans a majority on the City Council and judge us accordingly. While state government is completely controlled by the other party, you'll be putting Niagara Falls in the hands of local people who will put taxpayers first, all while engaging with our Democrat colleagues in a healthy

relationship that puts the city's best interests first, regardless of who our next mayor is.

Republicans don't always agree with one another. Councilman Tompkins and I often go separate ways, and that's a healthy part of our system. So by voting for two Republicans, you're not voting for a monolith with a singular agenda. We're all free-thinking individuals. But we will represent a change from decades of One Party Rule.

Let me end by saying I am bullish on Niagara Falls. While there are an abundance of challenges facing the city, we are blessed with an abundance of opportunities. On January 1st we will have a new mayor and one new council member. I believe we will eventually come to terms with the Senecas and build a new and meaningful relationship, and this will result in additional revenues that, if invested wisely, could help us take advantages of the opportunities in front of us.

New leadership, along with a little luck and much-needed help from God Almighty, will lead to better days ahead.

"This event is growing all time and it supports up to 15 non-for-profit organizations between the two cities," said Peter Chenier, President of the Canal Festival. "It supports the boy scouts, volunteer fireman and a number of churches."

This year there are dozens of vendors selling everything from funnel cakes to fried dough. More than 200,000 are expected to hit the streets over the course of the eight day event.

Emileigh Mazurkiewicz was crowned queen of the 2019 Canal Festival. For her the pageant is more than just wearing a crown, but rather representing an area that she loves and helping to inspire the next generation of young girls.

"As the queen I try and be a role model to all of the younger girls and show them that if you have strong well-rounded qualities that you can do anything" said Mazurkiewicz.

One of the highlights of the event is a chalk drawing contest. This year's theme is safari and the artists are judged in three separate categories. The age groups run from 6th grade and under, 6th grade to 12th grade, and then adults. Prizes are given out the winners and the contestants are judged individually.

"You think that the kids are just going to do something small, like how they would on a piece of paper, and then it turns into this 8' x 10' mural and it is wonderful how they incorporate the shading," said Emily Ertel, Chalk Festival, Co-Advisor. "The thought and creativity, all in just a matter of three and a half hours,

is off the charts."

Members of the National Guard were also at the event. They came to show people what they do and to educate young kids about how it can also be a rewarding career.

"We offer 100 percent tuition to any New York State, SUNY, school so you can go to UB or Buffalo State for free," said Sargent James Farley, National Guard. "Your total obligation is one weekend a month and two weeks in the summer,".

In addition to being educated about other organizations, some people came to just look at the canal and enjoy all of the beauty it has to offer.

"This is an annual tradition for me," said Michelle Jaynes, Tonawanda Resident. "The food is great and I like the games. I especially like the craft shows."

Water Bike Adventures offers people the chance to not only look at the canal but to ride on it. For \$12 an hour people can bike or paddle their way through its many paths.

"An hour is usually just enough time because after that people get tired and this is a really good location because we are right on Gateway Harbor and you can go out the creek or up the canal," said Abby Chilton, Water Bike Adventures.

In addition to celebrating the canal organizers are hoping people will stop into the shops along Webster Street and add a much-needed boost to the local economy. All helping to celebrate the canal and bring additional tourism to the area long after the event is over.

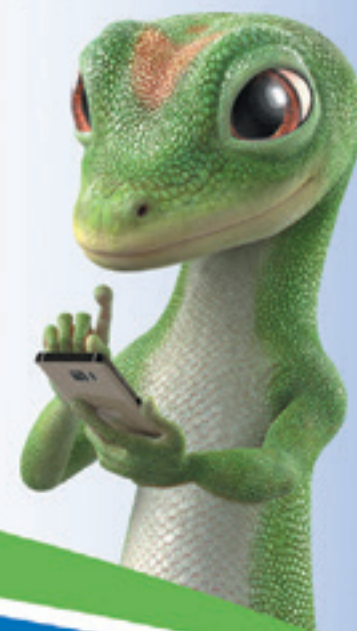
