Diodate Debacle Unfolds as Tompkins Has Last Laugh

"It was a bad hire," said Niagara Falls Republican Councilman Ken Tompkins on Monday referring to the 4 to 1 vote by lawmakers in January of 2018 approving Mark Diodate for the \$37,000-plus position of secretary to the council.

Tompkins, who cast the lone negative vote against the hiring of Diodate and was against the move from the start, said he had lied on his resume numerous times and was still approved.

"There were red flags on his resume that should have disqualified him," said Tompkins, adding that Diodate's recent arrest for coming into city hall after work to pad his final paycheck should come as no surprise given his false claims in his resume about his employment history.

Tompkins, who is up for re-election in November, clearly suggested that politics may have played a role in Diodate's hire by the Democratic majority even though fellow Republican Chris Voccio voted with the three Democrats who make up the majority.

Tompkins refused to comment further but other GOP sources suggest Diodate was backed for the patronage post by Democratic party leaders and the council went along with their wishes.

Democratic leaders declined to speak on the record about Tompkins'

charges that Diodate was the golden boy, but one high-ranking party official said that's not how the party operates and said it is the Republicans who have flooded the city, county and towns with "unqualified hacks" for 20 years, and that's not how Democrats operate.

Tompkins has strong ammunition for his charges of "red flags" as a former employer, in a public letter, characterized Diodate's work as a sales and managing partner as portrayed in his resume as "inaccurate and deceitful," according to published reports in the Niagara Gazette.

Diodate apparently has lost his bid for a position with the Board of Education because of the three felony counts he now faces.

Niagara County District Attorney Caroline Wojtaszek said Diodate is accused of coming into city hall after hours and adding additional hours to his payroll record on a city computer in order to increase his final paycheck.

Diodate has pleaded not guilty to three felony charges and a misdemeanor count in connection with his arrest and his Buffalo attorney, Herb Greenman, could not be reached for comment.

The latest political flap is a sign of the high stakes involved in November's election as Republicans are hoping to take control of the council, ending Democratic control.

Incumbents Tompkins, Voccio, and newcomer John Spanbauer are

hoping to give the GOP a council majority in the coming year, and Tompkins' salvo at the council's hiring of a flawed Diodate is a major shot at Democratic leadership. Di-

odate added fuel to the political fire by allegedly trying to steal money from the city on his way out the door.

develop though -about our once great city- the question is always the same. Always.

“How could that happen? How is that possible?”

That a city with one of the greatest natural resources on Earth, on a major international border, with over 7 million tourists per year, could lose half of its population, become virtually unsafe to live in, financially insolvent, and teetering on the brink of bankruptcy?

How could that happen?

How is that possible?

The short answer -my default- is that a small group of people have profited for decades off of the demise of a city.

The outgoing Administrations did not alone create this problem. But, they damn sure didn't do anything to fix it either. They came into office 12 years ago with nearly a \$7 million a year surplus. I'm not talking about casino money either. I'm talking about the money the city makes conducting its day to day affairs.

Every.

Single.

Penny. Has been squandered.

And, we are instead handing the next Administration a multi-million dollar per year deficit.

We are handing them a sinking ship.

It's one hell of a mess.

So, what do we do?

One of the people I look up to the most tells me on a regular basis that “everything happens for a reason”. My response is always the same,

“I don't know. I just don't know.”

I've been involved in a number of political campaigns. A fact that drives my poor mother completely insane.

Every political season I see the

same thing. A bunch of rats -usually with their pockets full- scurrying from a sinking ship.

Red vs blue, black vs white, one religion vs the other... and they're all just polishing the brass on the Titanic.

The city is dying. We got here because -for decades- corrupt people used the resources of this city purely to secure and maintain their own power. And, while that was happening, good men did nothing.

This is not the doom and gloom you think it is though. This time there is hope.

One guy in this picture isn't like the others. Truth be told, he's in this boat on accident. He wasn't even supposed to be here, right now. Or was he?

Maybe everything happens for a reason.

For 6 months- he has been saying the same thing and shouting it from the rooftops.

Stop. Fighting. Each other.

The ship is sinking.

It doesn't matter what side you're on.

It is going to take all of us, from all parties, from all colors, from all faiths, from all neighborhoods and nearby towns to save this city.

These are not my words, I'm just a guy with a pen.

These are the words of Bob Restaino.

I have listened while he has delivered this same message in both black and white communities, in both affluent and poor neighborhoods, to immigrant families and those that have been here 5 generations. His message has not changed.

Unity. We will get out of this mess together. And, I believe he is the one to lead the way.

I've been to two of his events, as a guest. Both times they were at the two biggest halls in the city. Both times they were packed wall to wall. Standing room only.

So, I spent time with him and his team to find out why this is.

The long of the short is he's a really smart guy. Smart enough to figure us a way out of this mess. But, that's not the thing of it.

The thing of it is this. The loyalty I've seen him receive from the people around him -young and old- is like nothing I've experienced before in the political process. Every time I've seen the guy, he's had an army of people with him and

they're all there -by choice- working for free.

Why? What inspires that kind of loyalty?

The more I've gotten to know him, the more I have realize this message of unity is real. He's never wavered on it. Never changed his tune to fit the group he was talking to.

I pushed his team several times to let me buy him lunch to get me some one on one time for my article. In my experience politicians never turn down a free meal. Every time the answer was the same, “he's out walking door to door”.

Not one to be turned away easily, I finally said “Fine. I'll work for him for free for the day. I'll walk with Bob.”

However, this was not the quick ‘show your face in the neighborhood’ that I had expected. Honestly, I'm 20 years younger than him and I went home that night absolutely exhausted, while he went off to another meeting.

I've been around plenty of politicians that can really talk. This might be the first time, however, that I walked with one who can really listen. At every door, to every resident, in every neighborhood. He listened.

I'll say again, his message of unity is real. But I found that being the smartest guy in the room was not the reason for the overwhelming loyalty from his army.

It's because he's the hardest working guy in the room. I found that out the hard way.

One -now retired- employee of his perhaps put it best “Working for Bob Restaino is not a free ride. You'll be expected to work. But, you can plan on him being the first one in and the last one out. He could very well become the greatest Mayor this city has ever had.”

After 30 years of neglect, that's exactly what this city needs.

Election Day is November 5th. Unity.

Niagara Falls National Heritage Area, a part of which supports the city's Underground Railroad Interpretive Center, but for many of the other activities that he has supported over the years in the African-American community as well as others. Williams recently accepted an opportunity from the former Erie County GOP Chairman Nick Langworthy. Langworthy was recently elected as the chair of the NYS Republican Party.

The press release that Langworthy disseminated cited Williams as saying, "When Chairman Langworthy asked me to serve in this position, I jumped at the chance because I know it is the start of a new era for the New York Republican Party. We have seen the disastrous effects of one-party Democrat rule on taxpayers of the state ..."

Williams' pointed out "one party Democrat rule" in his citation, but I have known 'Jeff' for more than 20-years, both us separately and sequentially throwing our hats into the ring for state senate, and I know that he, like myself, would also not-be-so-excited about the 'one party rule' of either or any party; as such would devolve into an autocratically one man rule, be it socialist or fascist.

Williams accepted my offer for an interview:

HAMILTON: You seem pretty exuberant about taking on this job and I have confidence that you can do it well. What is it that you hope to accomplish?

WILLIAMS: I have believed for years that we (Republicans) have missed the mark as a party in finding resources for our races from a grassroots level. I think that we can build a network of two-to-3,000 people giving at a rate of about \$20 a month in raising an enormous amount of money in order to help candidates across the state. And it does 2 things; anyone who gives a dollar for your campaign is someone who is voting for you. So, we are not only building finances, we're building voters. As we work to build this grassroots network across the state we are going to be strengthening the party at the same time. It is really an evolution, not truly a revolution. As the party evolves and we continue to rebuild it, retool it, and revitalize it we will start winning elections at local levels, county levels and eventually state level races.

It is a very important thing to have competition in any state, no matter how 'blue' the state is. We hope that there's a lot of Republicans in up-state NY, there's a lot of Republicans in [NYC], there's a lot of Republicans in Long Island, that it shows them that we are an alternative to what they are voting for at this point.

HAMILTON: How did we become a one-party state in three houses?

WILLIAMS: I believe that it was someone who was asleep at the switch. We had a state party that wasn't raising money, that was doing it [running the GOP] for themselves and not for the party. And that's

where we are trying to make a shift. We are trying to build a grassroots level so that this is everybody's party, not just one person's or a few people.

When Nick and I discussed this in the beginning, Ken, he liked my philanthropic-side as much as he liked my political-side. We've [Langworthy] known each other for almost as long as I have known you, but he is a lot younger; and I believe that it is things like Unity Day here, like we are having today, which I supported since the very first year when [Starks] walked into my office and asked me to help. I supported it because he does great things.

It's not about maybe the whole place is Democrats and I might be the only Republican in the room. It doesn't really matter. It's about building a base and building grassroots. And that's what we want to do with the party; we want to unify and bring it together so that it is a party for everyone, and not a party for the few.

HAMILTON: Are there any other African-American-centric events that you support?

WILLIAMS: Ken, if had I looked down the list I would have to go and look. I'm sure there are. I don't know at this point because I give to things that so well. I don't give care if they are African American-centric or any (thing else). Today I 'm doing 2 things: I've sponsored the jazz festival in Lewiston and I've sponsored Unity Day in Niagara Falls.

You know; for my entire day I am going to events that I have sponsored, and whether it's jazz festival in Lewiston – which is an amazing event, or Unity Day in Niagara Falls – which is just as amazing event, just a different event, I support excellence. It's not about party, it's not about race, it's about excellence.

HAMILTON: You have never been nailed to the Republican Party; I have always seen you working with people from other parties and from other ethnicities, etc..

WILLIAMS: I have always worked with all parties and I still continue to this day to have friends on all sides. Some of my best friends are Democrats, some of my best friends are Republicans; but we don't talk about those things, we talk about how to make things, and this place, better. It is important to make your community a better place, to make your state a better place. It's about service, and that's why I am doing this.

HAMILTON: In no particular order, what would you say are the 3 best things that can happen in Niagara Falls?

WILLIAMS: People recognizing the value of the city, people becoming more optimistic about the city they live in – and that's what this event does, it creates a sense of optimism that there's some hope; and then once we have those 2 things in place, rebuilding this city.

HAMILTON: Thank you, Jeff.



Labor Day is next Monday. For most, it marks the sad conclusion to our summer - the last chance to enjoy a final summer cookout, roller coaster ride or day at the beach. Political speeches have become an integral part of the holiday marking the time when much of the public usually starts to pay attention to the campaigns. But more importantly it is a time Americans think about the sacrifices unions have made, as it relates to wages and safety issues. This national holiday, celebrated every first Monday in September, arose as a tribute to the greatest of all things – the American worker. The first Labor Day holiday was celebrated on Tuesday, September 5, 1882, in New York City, in accordance with the plans of the Central Labor Union. In 1884 the first Monday in September was selected as the holiday, and the Central Labor Union urged similar organizations in other cities to follow the example of New York and celebrate a "workingmen's holiday" on that date. The idea spread with the growth of labor organizations, and in 1885 Labor Day was celebrated in many industrial centers of the country. Despite the celebrations every year, Labor Day actually ascended from a tragic conclusion to a labor strike. President Cleveland and Congress unanimously created the nationally recognized holiday in 1894 after intervening in the Pullman Strike that resulted in the death of numerous workers at the hands of the U.S. military and U.S. Marshals. Labor Day stands as a creation of the labor movement and is dedicated to the social and economic achievements of American workers. It constitutes a yearly national tribute to the contributions workers have made to the strength, prosperity, and well-being of our country. The vital force of labor added materially to the highest standard of living and the greatest production the world has ever known and has brought us closer to the realization of our traditional ideals of economic and political democracy. It is appropriate, therefore, that the nation pays tribute on Labor Day to the creator of so much of the nation's strength, freedom, and leadership — the American worker. Today, all U.S. states, the District of Columbia, and the territories have made it a statutory holiday.

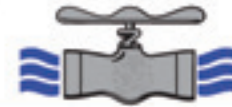

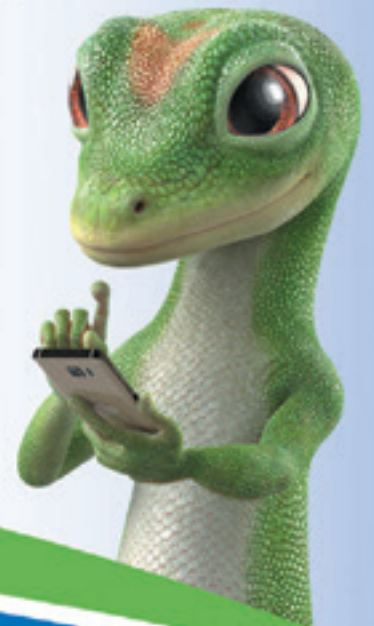
